The Green Party is concerned with the full range of issues facing Albertans today. The Green Party believes in the strengthening of the community, the renewal of democracy, the restoration of the environment and building a sustainable economy. We are a forward-looking party. We offer a new platform for genuine progress and real change.

STRENGTHENING THE COMMUNITY

A Green government will restore and strengthen local communities by fostering greater local autonomy.

Health and Healing

We believe that the health of Albertans must be the primary focus of our health care system. The Green Party will reduce the factors contributing to illness and disease, through increased prevention, greater choice, and decentralization of health care facilities. Health care resources must be safe-guarded through conflict of interest legislation. These are the key values that will guide our *Health and Healing* program.

Superior Public Education System

The Green Party will work to provide proper funding for a *Superior Public Education System*. Albertans deserve the excellent primary, secondary and post-secondary education. Green Power

*An open letter to
Finance Minister Paul Martin

I am writing on behalf of the Alberta Greens (Green Party of Alberta) to strongly endorse the initiative by the Clean Air Renewable Energy (CARE) coalition that has put together two ideas of which I am sure you are familiar. CARE is a coalition of environmentalists and industrialists who both agree that the time for action has arrived and believe that change will only come when government policy promotes positive movement.

The two initiatives are:

1. A consumer tax credit for purchasers of electricity from sources such as wind, sun and biomass fuels.
2. A broader investment-tax credit for green power research and development.

The effect, the group contends, and the Alberta Greens concur with, would be a reduction in the emissions that cause urban smog and global warming. Arguably these two environmental problems are first and foremost in the minds and concerns of most Canadians. Both are worldwide in scope and both result from the same activity, the burning of fossil fuels. All the major cities of the planet are beset in varying degrees by the problem of urban smog, the severity is usually affected by local topography and climate. Climate Change, on the other hand, leaves no one unaffected and is massively more destructive, costly and unpredictable in the resulting effects.

Industrial participants so far involved are Suncor Energy, Shell Canada, BP Canada, TransAlta and Westcoast Energy. It

has been obvious for several years that a change away from dependence upon non-renewable resources is long overdue and critical to Canadian fiscal viability. Although Canada produces many of the energy sources responsible for worldwide pollution and ecological destruction we also are at the whim of a few major producers. Money spent on energy is not available for social problems, investment, environmental remediation, reducing taxation, health and education, all of which are the highest concerns of our population. Please take heed of these forwardly thinking corporate entities and instigate the proposals agreed on.

Presently tax policy favours the burning and wasting of energy. The motto of all Green Parties is "Tax the Bads, Not the Goods". We realize that many with vested interests benefit from the status quo and reap huge profits from ecological destruction. The playing field must be leveled and indeed tipped in a direction favourable of sustainable practices. Such an outcome will in fact ensue over time, as environmental destruction gains even greater momentum and more people are adversely affected, but can be greatly advanced by government policy. We ask that the good offices of the Canadian finance department act in a manner beneficial to all Canadians and not merely a few investors in such places as Calgary, Houston and Saudi Arabia.

In an economy with options beyond the burning of fossil fuels other, less developed, regions can become involved in the economy. Non-renewables are available everywhere and, with the right taxation and fiscal policies, can be exploited anywhere. The world is moving toward a sustainable future and Canada can become a leader in technologies suitable to the new age but not without leadership and financial commitment from government. The sunset industries were promoted in this way a century ago, it is now time to shift that focus to industries compatible with the 21st century.

The enormous growth in concern over environmental destruction should be an indication to you that people want to do

the right thing. Canadians still want to invest for their retirements but no longer in practices that will make that retirement unendurable. People are realizing that all the investment income in the world will not allow them to escape the future that income is creating.

The Liberal Party of Canada has moved in recent years towards private sector solutions to Canadian problems, these recommendations are such initiatives. Let the private sector develop the required technology and market it but take away the props from the old economy, which is impeding the growth of the new. Shift the subsidies, infrastructure grants and tax breaks towards the industries that will provide us with a future we can live in.

To reiterate, these technologies will become reality but the financial rewards will go to entrepreneurial countries without the ball and chain of developed fossil fuel industries. Canada must bite the bullet and become a clean economy.

Trashy Ideas

While the August 10, 2000 *Eye* editorial rightly encourages Toronto to reduce garbage volume by aggressive composting like Halifax or a wet/dry system like Guelph, your recommendation doesn't go far enough. With assistance from the federal and provincial governments the waste stream could be reduced to near zero. The principles of sustainable development suggest that there should be no such thing as garbage.

The onus for reducing curbside and industrial garbage should be placed on the manufacturer not on the consumer. People have few options when trying to avoid single-use packaging or disposable products when shopping. Municipal pay-per-bag by-laws and higher

tipping fees should be avoided since they place the blame at the wrong end of the product's life cycle, though they do encourage existing recycling and composting programs.

The long-term solution would be to stop producing garbage. Every product should be designed to be repaired, reused, recycled, or composted. Industrial processes should use materials in closed-loop, continuous cycles. A garbage-free society would conserve resources and thus eliminate the need for dumps. And the economy will benefit since re-using materials is labour-intensive rather than material-intensive, there being many more jobs in repair, reuse and composting than in single-use disposal.

While municipal recycling and composting programs can significantly reduce the waste stream, the only way to a zero-garbage society is through legislation and taxation – which are provincial and federal government jurisdictions. Manufacturers should be taxed on their per unit production of disposable products and packaging. Reusable, repairable, compostable products and packaging should be tax free. Industries, which always follow the path of least tax resistance, would quickly phase out disposables.

Tariffs at the border could impose import taxes on single-use products to ensure a level playing field for local manufacturers.

A Visit with Three Oxford Greens

CAROLINE

Elected in 1993 Caroline Lucas was the first Green to sit on the Oxfordshire County Council. Six years later she became one of two English Greens elected to the European Parliament. Quoted in the pamphlet *Why women should join the Green Party*, Caroline (an aid agency policy advisor and Oxfordshire County Councillor at the time) stated:

"Green politics is about a new way of relating to the world and to each other. The core values at the heart of our philosophy - equity, peace sustainability - make the Greens the only radical party in Britain."

In May 2000, just 7 years after Caroline was first elected, the Oxford Greens won their tenth municipal seat in the City of Oxford. They now jointly run the City with the Liberal Democrats, having ousted Labour after 20 years in power.

This is no grand coalition. Rather the Greens proposed a joint administration of all Council business when no one party secured a majority in the 2000 election. Labour refused, so the Greens hammered out an agreement that they would share the administrative workload, provided they were free to vote on each item according to its merits.

Less than two months later some Liberal-Democrat and Labour councillors (with views closer to the Greens) have started to vote with the 8 Greens as a bloc - preferring the Green way to simply toeing the party line. But what is even more remarkable about these Green pioneers is the fact that they each received upwards of 44% of the vote in electoral contests with up to five other opponents.

That's right. These Greens are winning in a "first past the post" system!

ELISE AND CRAIG

Meet, for example, East Ward Councillor Elise Benjamin (her life partner, Craig Simmons, is the County Councillor for St. Clement's Ward and has just completed writing a book on ecological footprints with Mathis Wackernangel). Elise lives on the Magdalen road, is a governor at East Oxford First School, Vice Chair of East Oxford Adventure Playground, and a member of Bloominarts Management Committee and the Levellers Day committee. Prior to her election in 1999 she also sat on two City Council Committees and administered the local LETS scheme.

Their house is piled high with Committee papers, they are in the middle of renovations and about to go away for a much needed vacation. When I arrived Elise is meeting with the person who will take over her LETS position, Craig is still at work across the street, and for over an hour the phone never stops ringing or being used. Elise states:

"I was elected because the Greens are the only party in Oxford that actually wants to represent the people. We are not elected because we are Greens, but because we are ordinary people who care enough to get involved and want to change the political system,

You know, there is this Councillor up in Bradford (an inner city ethnic ghetto in Yorkshire) who took 12 years to get elected, and the Green group in Huddersfield simply decided to go door to door and take on the casework the other parties' elected Councillors were ignoring."

Elise took a more modest five annual elections before she earned the right to sit at the Council table. In England municipal councils are elected on a four year rotation - three years of parish, town, city and district elections, with a fourth year at the county level.

In 1993 Greens took 12% of the vote in East Ward. In 1995 Elise pushed that to second place with just under 20% of the vote. Then came the long hard slog in

1996, 1997 and 1998, when the vote climbed to 42%. Finally in 1999 Elise won with 48.4%.

She now has three years to convince voters she should stay there. In neighbouring Central and St. Clements Wards the Greens have gained control of all six City Council seats and both County Council seats since 1993. Elise's win was the first outside the "granola" belt of students and alternative lifestyles and in 2000 the Green Party took their first seat in South Ward.

A visit to Elise and Craig's back yard reveals both a wind generator and solar panel which create enough electricity to heat the greenhouse and run a lamp in the sitting room.

What are some of the issues that Elise and the Greens focus on in Oxford? Here's a list from one of their pamphlets.

- Poverty and Regenerating the Local Economy
- Improving Housing and Services to Homeless
- Reducing Pollution and Waste
- Managing Transport and Sensible Planning
- Local Democracy
- Crime and Community

In the centre of the pamphlet under the title *Green Action*, 48 campaigns are listed, with 25 having arrows pointing to a place on a map in East Oxford where this work has been undertaken. Out on the street neighbours come up and chat and raise issues as we walk over to a community business district for an evening meal.

The east Asian restaurant staff are pleased to see their local councillors and later another shop owner banter that a restaurant in another part of the district has better food. In East Oxford it is the Greens who are champions of small business and regenerating the local community.

"We used to be laughed at for our policies of local control and community economics," Elise says. City staff were

ordered not to share information with the Green councillors. But in Oxford, thanks to "Free Trade" in Europe, the Rover car works has shrunk from 25,000 employees down to 2,500 and 1,500 of those are on lay-off.

At this point in our evening meal a debate ensues over the merits of promoting tourism and whether or not the other parties' new found interest in building local economies is more out of self-preservation than an actual conversion to real economic change.

"We have our fundi's too," grins Elise, talking about the third member of our supper gathering. Then she goes on to admit that she has little time for the holier than thou members of the party who go to meetings to participate in endless policy debates. She sees these people as bureaucrats who are not faced with the reality of being an elected Green politician.

Elise and Craig are originally from London, and their politics are played out in the daily grind of life in the back-to-back housing in the inner city district of East Oxford. With the fall of Labour, Greens and Liberal-Democrats are reconstituting the East Oxford parliament - the first meeting of which saw over 150 citizens come out and say they wanted more control, not less, over their daily lives as well as input in proposals for their community.

Their friend, by the way, for all his complaints about internal Green politics and frequent *coup d'etats* at the top of the national party, is a key fund-raiser at election time. He pays for all the pamphlet production in East Oxford and then tries to raise the money to cover what he has spent.

Despite serious reservations and a deeply held cynicism he backs his "reallo" friends.

He despairs about the lack of Green consciousness among the English citizenry, and feels if the Greens ever took complete control of Oxford City Council and implemented stated policy they would be turned out on their ears at the next elec-

tion. In 2000 when the Labour Party targeted small businesses for posterizing, the Greens were able to counter with more business support. "We'd just never thought to ask them if they would place Green Party signs in their shop windows," stated Craig.

The night before the Thursday, May 4th, 2000 election, Green Party canvassers dropped 8,000 postcards into the mailboxes across three wards, reminding their identified voters that tomorrow was "E-day". By 6 PM voters who had not gone to the polls were being phoned: "Vote Green for a Change".

It is a constant balancing act representing people in Oxford, between stated aims and assisting the people on the day-to-day issues they are facing. Elise and Craig are more convinced that people are prepared to listen to Green ideas when they are seen to effectively address problems they face, however their friend is obviously not convinced that this is the correct path to follow.

If Greens in Canada want to start electing Green candidates they are going to have to build the same election machinery as the Oxford Greens, develop the same long term links to the voters and citizens they want to represent, and weave their way through the same maze of policy development and complexities of implementation. As Elise remarks, and Craig agrees, the Oxford Greens have a better political machine than Labour does. "They became complacent and we have knocked the stuffing out of them," Elise chuckles.

What's obvious, looking around their house, is that these are two very committed party members who really care about the community and the people they represent.

In 1997 Craig Simmons was re-elected to Oxfordshire County Council on the same day as a British General Election. To his surprise he received the same percentage of the vote with more than double the turnout of a usual municipal vote (1 in 3). It was quite a disappointment that the same voters who elected him

municipally opted for other parties in the national election.

"Greens," he muses, "will only be elected to government positions that the citizenry feel they are ready for...and where they have a chance of winning."

US Green Party Showing in Election'2000

Ralph Nader's 2.7% is the third best showing for a US minor party presidential candidate in the last 75 years. The only parties which did better, since 1924, were been the American Independent Party in 1968, and the Reform Party in 1996. Nader's showing topped the best that Norman Thomas ever did (2.2% in 1932), and also tops former vice-president Henry Wallace's 2.1% in 1948 (however, independent presidential candidates John Anderson in 1980, and Ross Perot in 1992, did better than Nader).

The Green Party won two partisan races this month: Art Goodtimes was elected County Commissioner in San Miguel County, Colorado; and Julie Jacobson was elected to the Hawaii County Council (although the voters of Hawaii County this year voted to make that office non-partisan in the future). Greens also won at least 14 non-partisan elections, and now have a 3-2 majority on the city council in Sebastopol, California.

Green candidates for US House polled almost 300,000 votes, and for the US Senate, approximately 650,000.
